KNOXVILLE LAWYER REINSTATED BY SUPREME COURT

Whitney Suzanne Bailey has been reinstated to the practice of law by Order of the Tennessee Supreme Court entered May 31, 2013, subject to several conditions. The conditions include evaluation by TLAP and engagement of a practice monitor. Ms. Bailey is also ordered to pay the Board's costs in this matter.

Ms. Bailey was temporarily suspended from the practice of law by Order of the Supreme Court on April 26, 2013, for failing to respond to a request for information. On May 1, 2013, Ms. Bailey filed a Petition for Dissolution of the Temporary Suspension. On May 24, 2013, a Hearing Panel entered a recommendation that the temporary suspension be dissolved, subject to conditions.

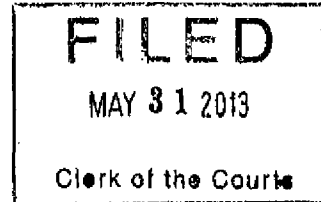

ORDER

On April 26, 2013, the Court entered an Order of Temporary Suspension suspending Whitney Suzanne Bailey pursuant to Tenn. Sup. Ct. R. 9, § 4.3, due to Ms. Bailey's failure to respond to requests for additional information. On May 1, 2013, Ms. Bailey filed a Petition for Dissolution of Temporary Order of Suspension.

On May 22, 2013, a hearing was conducted before a three-member Hearing Panel of the Board of Professional Responsibility. On May 24, 2013, the Hearing Panel entered its Report and Recommendation that Ms. Bailey's temporary suspension be dissolved subject to conditions. A copy of the Report and Recommendation is attached hereto and incorporated herein by reference.

It is, therefore, ordered, adjudged and decreed by the Court:

1. The temporary suspension imposed on Whitney Suzanne Bailey by Order of Temporary Suspension filed April 26, 2013, shall be dissolved.
2. Ms. Bailey shall engage a licensed member of the Bar to serve as her practice monitor subject to approval of Disciplinary Counsel. Respondent and her monitor shall have weekly telephone conferences and monthly meetings. Respondent shall cause the practice monitor to make quarterly status reports to Disciplinary Counsel. Respondent shall be responsible for the payment of the practice monitor, unless the practice monitor agrees to perform the work *pro bono*.
3. Respondent shall be required to complete an evaluation with TLAP, and any other evaluations recommended by them. If TLAP determines that a monitoring agreement is appropriate, that agreement must be signed and Ms. Bailey must comply with all terms and conditions of the TLAP monitoring agreement.

4. In the event Ms. Bailey fails to meet any condition of the Hearing Panel's Report and Recommendation or this order, Disciplinary Counsel shall file a petition for her immediate suspension from the practice of law to ensure the protection of the public.

5. Ms. Bailey shall reimburse and pay to the Board of Professional Responsibility the costs and expenses incurred herein in the amount of \$109.63 within ninety (90) days, and pay to the Clerk of Court all court costs, for all of which execution shall issue, if necessary.
