AMENDED ORDER

This matter is before the Court upon the Petition for Discipline, Supplemental Petition, Second Supplemental Petition, Third Supplemental Petition, Fourth Supplemental Petition and Fifth Supplemental Petition of Disciplinary Counsel for the suspension of Kathleen L. Caldwell, Respondent, pursuant to Section 4.2 of Tennessee Supreme Court Rule 9. The Petitions are based on eighteen (18) separate complaints lodged against her with the Board of Professional Responsibility in complaint numbers 18208-9-LC; 18671-9-LC; 19395-9-LC; 19596-9-LC; 19826-9-LC; 20232-9-LC; 22961-9-LC; 23336-9-LC; 23634-9-LC; 23992-9-LC; 24070-9-LC; 24565-9-LC; 24686-9-LC; 24770-9-LC; 24750-9-LC; 25083-9-LC; 25232-9-LC; and 26163-9-LC. The Petitions have been authorized by the Chairman of the Board of Professional Responsibility. Ms. Caldwell has been charged with violating Disciplinary Rules 1-102(A)(1)(5)(6); 2-106(A)(B); 2-110(A)(1); 5-105(A); 6-101(A)(1)(3); 7-101(A)(1)(2)(3)(4); and 9-102(B)(4) of the Code of Professional Responsibility.

Pursuant to Rule 9 § 16.1 of the Rules of the Tennessee Supreme Court, Ms. Caldwell has agreed to enter into a Conditional Guilty Plea to the Petitions. This conditional plea of "guilty," to which reference is hereby made and which is herein incorporated by reference, has been approved by the Board of Professional Responsibility.


It is hereby, **ORDERED, ADJUDGED and DECREED** by the Court:

1. Pursuant to the Conditional Guilty Plea, Ms. Caldwell shall be suspended for ninety days from the practice of law. This suspension shall begin on October 15, 2003. Ms. Caldwell shall comply with the conditions set forth in the Conditional Guilty Plea, which are incorporated herein by reference, within one year from the date of this Order. In the event Ms. Caldwell fails to comply with any of the aforementioned conditions within one year, it will be grounds for ~~immediate~~ *as* summary suspension of her license to practice law until she complies with such

condition(s). Ms. Caldwell shall fully comply with all applicable provisions set forth in Supreme Court Rule 9, Section 18.

2. Pursuant to Rule 9 § 24.3 of the Rules of the Tennessee Supreme Court, Ms. Caldwell shall reimburse and pay to the Board of Professional Responsibility the expenses and costs of this matter in the amount of \$6,415.84. In addition, she shall pay the Clerk of this Court the costs incurred therein, for all of which execution shall issue if necessary.
