**SUMNER COUNTY LAWYER CENSURED**

On October 8, 2013, Tonya Hunt Crowlover of Hendersonville, Tennessee, was Publicly Censured by the Tennessee Supreme Court pursuant to Tennessee Supreme Court, Rule 9, Section 4.4.

Ms. Crowlover committed the unauthorized practice of law by representing a client after she had been administratively suspended for failing to comply with her continuing legal education requirements.

By these acts, Ms. Crowlover has violated Rule 5.5 (unauthorized practice of law) of the Rules of Professional Conduct and is hereby Publicly Censured for this violation.

A Public Censure is a rebuke and warning to the attorney, but it does not affect the attorney's ability to practice law.


PUBLIC CENSURE

The above complaint was filed against Tonya Hunt Crownover, an attorney licensed to practice law in Tennessee, alleging certain acts of misconduct. Pursuant to Supreme Court Rule 9, the Board of Professional Responsibility considered these matters at its meeting on September 13, 2013.

Ms. Crownover practiced law by attempting to schedule a Benefit Review Conference on behalf of a client while her license to practice law was administratively suspended for failure to comply with her annual CLE obligations. By the aforementioned acts, Tonya Hunt Crownover, has violated Rule of Professional Conduct 5.5 (unauthorized practice of law) and is hereby Publicly Censured for this violation.
