## ORDER OF ENFORCEMENT

This cause is before the Court on a Petition to Reinstate Law License filed by the Petitioner, Stanley D. Darnell, on December 2, 2003, pursuant to Section 19 of Supreme Court Rule 9. By Order of Enforcement entered May 15, 1991, the Petitioner was suspended for two years retroactive to September 12, 1990, the date on which he had been temporarily suspended by this Court pursuant to Section 4.3 of Supreme Court Rule 9. The Petitioner was suspended for an additional sixteen months retroactive to September 12, 1992, by Order of this Court entered January 11, 1995. On August 11, 2004, a Hearing Panel of the Board of Professional Responsibility conducted a hearing on the Petition for Reinstatement. The Findings and Decision of the Hearing Panel, attached hereto and incorporated herein verbatim by reference, was filed with the Board of Professional Responsibility on September 29, 2004. The Hearing Panel found that the Petitioner had carried his burden of proving the requirements of Section 19.3 of Supreme Court Rule 9 by clear and convincing evidence and recommended that the Petitioner's license to practice be reinstated upon conditions set forth in it s Order of Reinstatement.

Neither the Petitioner nor the Board of Professional Responsibility seeks appeal of the Hearing Panel's Order of Reinstatement. The Petitioner has entered into a contract with Peter M. Olson, Esquire, to serve as Practice and Trust Monitor for the Petitioner, as required by the Findings and Decision of the Hearing Panel.

It is, therefore, ORDERED, ADJUDGED, and DECREED by this Court that the Findings and Decision of the Hearing Panel filed on September 29, 2004, including all conditions of the reinstatement of the Petitioner to the practice of law, are approved and entered as the Order of this Court.

It is further ORDERED by the Court that Stanley D. Darnell shall pay the costs of these proceedings and, in addition, shall pay the Clerk of this Court the costs incurred, for all of which execution shall issue, if necessary.
