**McNAIRY COUNTY ATTORNEY PLACED ON DISABILITY INACTIVE STATUS**

By Order of the Tennessee Supreme Court entered July 27, 2017, the law license of Bobby Gene Gray, Jr., was transferred to disability inactive status pursuant to Section 27.3 of Tennessee Supreme Court Rule 9. Mr. Gray has also been temporarily suspended by Order of the Tennessee Supreme Court on this date due to conduct that poses a risk of substantial harm to the public.

Mr. Gray cannot practice law while on disability inactive status. He may request removal of disability inactive status upon showing of clear and convincing evidence that the disability has been removed; however, Mr. Gray cannot be reinstated to the practice of law until he has requested, and been granted, reinstatement from temporary suspension.

**ORDER TRANSFERRING ATTORNEY TO  
DISABILITY INACTIVE STATUS**

This matter is before the Court upon a petition to transfer Bobby Gene Gray to disability inactive status filed by the attorney for Mr. Gray pursuant to Tenn. Sup. Ct. R. 9, § 27.3.

Upon due consideration of documentation from Bobby Gene Gray, the Court concludes that Mr. Gray is currently incapacitated from continuing the practice of law.

IT IS, THEREFORE, CONSIDERED, ORDERED, ADJUDGED AND DECREED BY THE COURT THAT:

1. The law license of Bobby Gene Gray shall be transferred to disability inactive status for an indefinite period of time and until further orders of the Supreme Court.
2. Mr. Gray shall be allowed to petition for reinstatement to active status pursuant to Tenn. Sup. Ct. R. 9, § 27.7.
3. Mr. Gray has been placed on temporary suspension which remains in full force and effect. (M2017-01451-SC-BAR-BP)
4. The Board shall publish notice of this transfer pursuant to Tenn. Sup. Ct. R. 9, §§ 27.5 and 28.11.
5. Pursuant to Tenn. Sup. Ct. R. 9, § 32.4, documents other than this Order relating to Mr. Gray's disability proceeding shall not be public records and shall be kept confidential.
