REVISED PUBLIC CENSURE

The above complaint was filed against Lawrence Buford Hammet, II, an attorney licensed

to practice law in Tennessee, alleging certain acts of misconduct. Pursuant to Supreme Court Rule

9, the Board of Professional Responsibility considered these matters at its meeting on December

11, 2020. On January 20, 2021, Lawrence Buford Hammet, II, an attorney licensed to practice

law in Tennessee, received a Public Censure from the Board of Professional Responsibility of the

Tennessee Supreme Court conditioned upon Mr. Hammet satisfying the judgment against him on

or before January 19, 2021. Mr. Hammet failed to timely pay the judgment in full.

On June 24, 2021, the Davidson County Chancery Court entered an Agreed Order for Slow

Pay wherein Mr. Hammet is required to make monthly payments to satisfy the judgment. A copy

of the Davidson County Chancery Court order is attached hereto as "Attachment A." On July 7,

2021, the Board of Professional Responsibility approved revising the Public Censure issued on

January 20, 2021 to be conditioned upon Mr. Hammet satisfying the judgments against him in

accordance with the Davidson County Chancery Court Agreed Order for Slow Pay entered on June

24, 2021.

Mr. Hammet withdrew disputed funds from his client trust account and paid himself a fee

which exceeded the amount that his client alleged was agreed upon at the commencement of the

representation. The client filed a civil suit against Mr. Hammet which was appealed after trial. The Court of Appeals found that Mr. Hammet failed to keep the disputed funds in his client trust account until the dispute was resolved and that Mr. Hammet improperly calculated his fees which were unreasonable. The Court of Appeals awarded judgment to the client in the amount of \$67,335.69 and remanded the case to the trial court for a determination of pre-judgment interest. The trial court subsequently awarded pre-judgment interest to the client in an additional amount of \$22,092.10.

By the aforementioned acts, Lawrence Buford Hammet, II violated Rule of Professional Conduct 1.5 (fees) and 1.15(e) (safekeeping property) and is Publicly Censured for these violations conditioned upon Mr. Hammet satisfying the judgments against him in accordance with the Davidson County Chancery Court Agreed Order for Slow Pay entered on June 24, 2021.

The Final Judgment is comprised of the principal amount of \$67,335.59 plus accrued interest at the rate of 5.25%, and the amount of \$27,569.15, collectively constituting the

portion of the Final Judgement awarding Prejudgment Interest and Discretionary Costs. Execution is STAYED as to Defendant Hammet if Defendant Hammet complies with this Order, but execution may proceed against Defendant Hammet if Defendant Hammet defaults on the terms herein. No stay of execution applies to Defendant Todd & Flovel, PLC.
