HAWKINS COUNTY LAWYER CENSURED

On June 25, 2019, Daniel Graham Boyd was publicly censured by Order of the Tennessee Supreme Court. Mr. Boyd must pay the Board's costs and expenses.

On June 22, 2018, the Board filed a Petition for Discipline alleging that Mr. Boyd failed to diligently represent his clients in a boundary line dispute and failed to adequately communicate with them. Mr. Boyd entered into a conditional guilty plea admitting that his actions violated Rules of Professional Conduct 1.3 (Diligence); 1.4 (Communication); 3.2 (Expediting Litigation) and 8.4(a) (Misconduct).

A Public Censure is a rebuke and warning to the attorney, but it does not affect the attorney's ability to practice law.

ORDER OF ENFORCEMENT

This matter is before the Court upon a Petition for Discipline filed against Daniel Graham Boyd on June 22, 2018; upon the Answer of Daniel Graham Boyd to Petition for Discipline filed by Mr. Boyd on August 22, 2018; upon entry of a Conditional Guilty Plea filed by Mr. Boyd on March 21, 2019; upon an Order Recommending Approval of Conditional Guilty Plea entered on April 26, 2019; upon consideration and approval by the Board on June 14, 2019; and upon the entire record in this cause.

From all of which the Court approves the Order of the Hearing Panel and adopts the Hearing Panel's Order Recommending Approval of Conditional Guilty Plea as the Court's Order.

IT IS, THEREFORE, CONSIDERED, ORDERED, ADJUDGED AND DECREED BY THE COURT THAT:

- (1) Daniel Graham Boyd is publicly censured, pursuant to Tenn. Sup. Ct. R. 9, § 12.4.
- (2) Pursuant to Tenn. Sup. Ct. R. 9, § 28.1, this Order shall be effective upon entry.
- (3) Pursuant to Tenn. Sup. Ct. R. 9, § 31.3(d), Mr. Boyd shall pay to the Board of Professional Responsibility the expenses and costs of this matter in the amount of \$1,021.65 and shall pay to the Clerk of this Court the costs incurred herein, within ninety (90) days of the entry of this Order, for all of which execution may issue if necessary.
- (4) The Board of Professional Responsibility shall cause notice of this discipline to be published as required by Tenn. Sup. Ct. R. 9, § 28.11.
