MADISON COUNTY LAWYER CENSURED

On October 25, 2011, Angela LaShandra Jenkins-Hines, an attorney licensed to practice law in Tennessee, received a Public Censure from the Board of Professional Responsibility of the Tennessee Supreme Court.

Ms. Jenkins-Hines utilized her trust account to pay personal and business expenses, such as rent payments, donations to her church, and purchases from various retailers. The trust account, however, contained only Ms. Jenkins-Hines' own funds.

By misusing her trust account, Ms. Jenkins-Hines has violated Rules of Professional Conduct 1.15 (safekeeping property) and is hereby Publicly Censured for this violation.

A Public Censure is a rebuke and warning to the attorney, but it does not affect the attorney's ability to practice law.

PUBLIC CENSURE

The above complaints were filed against Angela LaShandra Jenkins-Hines, an attorney licensed to practice law in Tennessee, alleging certain acts of misconduct. Pursuant to Supreme Court Rule 9, the Board of Professional Responsibility considered these matters at its meeting on September 9, 2011.

The Board received three overdraft notices pertaining to the Respondent's trust account. The Respondent's trust account records revealed that the Respondent utilized her trust account to pay personal and business expenses, such as rent payments, donations to her church, and purchases from amazon.com, Burlington, Wal-Mart, Office Depot, Walgreen's, and Autozone. The trust account contained only the Respondent's own funds.

By the aforementioned acts, Angela LaShandra Jenkins-Hines has violated Rule of Professional Conduct 1.15 (safekeeping property) and is hereby Publicly Censured for this violation.
