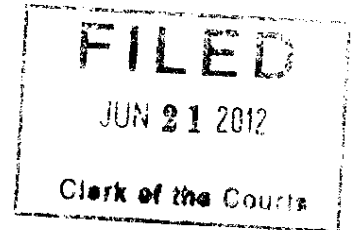

**ORDER OF ENFORCEMENT**

This matter is before the Court pursuant to Tenn. Sup. Ct. R. 9, § 14, upon a certificate filed by Disciplinary Counsel for the Board of Professional Responsibility consisting of certified copies of the jury verdict in a criminal case, *United States of America v. Jerry D. Kerley*, (attached as Exhibit A) filed in the United States District Court Eastern District of Tennessee on May 18, 2012, demonstrating that Jerry DeWayne Kerley, a Tennessee attorney, was found guilty of serious crimes, i.e., Conspiracy to Commit Wire Fraud Affecting a Financial Institution or Bank Fraud; Wire Fraud Affecting a Financial Institution Relating to the Purchase of Real Property; Bank Fraud in Submitting a False HUD-1 Statement Relating to the Purchase of Real Property; False Statements to Citizens Bank Relating to the Purchase of Real Property; and Money Laundering Relating to the Purchase of Real Property.

It is therefore, ordered, adjudged, and decreed by the Court that:

1. Jerry DeWayne Kerley is suspended from the practice of law on this date pending further orders of this Court, pursuant to Tenn. Sup. Ct. R. 9, § 14.
2. This matter shall be referred to the Board of Professional Responsibility for the institution of a formal proceeding in which the sole issue to be determined shall be the extent of the final discipline to be imposed as a result of the conviction by jury verdict.
3. Jerry DeWayne Kerley shall fully comply with the provisions of Tenn. Sup. Ct. R. 9, § 18 concerning disbarred or suspended attorneys.
4. The Board of Professional Responsibility shall cause notice of this suspension to be published as required by Tenn. Sup. Ct. R. 9, § 18.10.
