**ORDER OF TRANSFER TO DISABILITY INACTIVE STATUS**

This matter is before the Court upon the Petition for Transfer to Disability Inactive Status of Bryan Edwards Larson filed by Disciplinary Counsel pursuant to Rule 9, Section 21.2 of the Rules of the Supreme Court. The Board of Professional Responsibility asserts that Bryan Edwards Larson is incapacitated and cannot practice law. Evidence of Bryan Edwards Larson's condition has been provided as Exhibit A to the Petition.

It is, therefore, **ORDERED, ADJUDGED** and **DECREED** by the Court:

- (1) That pursuant to Rule 9, Section 21.2 of the Rules of the Supreme Court, Bryan Edwards Larson's license to practice law is hereby transferred to disability inactive status for an indefinite period and until further Order of this Court.
- (2) That pursuant to Rule 9, Section 25.2 of the Rules of the Supreme Court, this Order shall become a public record upon filing; however, all other documents relating to this disability proceeding shall not become public records and shall be kept confidential.
- (3) The Board of Professional Responsibility shall cause notice of this transfer to disability inactive status to be published as required by Rule 9, Section 21.4 of the Rules of the Supreme Court.

**NASHVILLE LAWYER PLACED ON DISABILITY INACTIVE STATUS**

By Order of the Tennessee Supreme Court filed October 22, 2008, the law license of Bryan Edwards Larson, a Nashville attorney, was transferred to Disability Inactive Status pursuant to Section 21 of Supreme Court Rule 9 for an indefinite period of time and until further Orders of the Supreme Court.

Mr. Larson cannot practice law while on disability inactive status. Mr. Larson can return to the practice of law only after reinstatement by Order of the Supreme Court.
