**NASHVILLE LAWYER REINSTATED BY SUPREME COURT**

Ivan Omar Lopez, a Nashville attorney, has been reinstated to the practice of law by Order of the Tennessee Supreme Court entered on August 11, 2010. Mr. Lopez was temporarily suspended from the practice of law by Order of the Supreme Court on July 21, 2010, due to his substantial noncompliance with his Monitoring Agreement with the Tennessee Lawyers Assistance Program. On July 23, 2010, Mr. Lopez filed a Petition for Dissolution of Temporary Suspension. On August 6, 2010, a Hearing Panel of the Board of Professional Responsibility recommended that the temporary suspension be dissolved. The temporary suspension was dissolved pursuant to the Supreme Court's August 11, 2010, Order.

**ORDER**

On July 21, 2010, the Court entered an Order of Temporary Suspension suspending Ivan Omar Lopez pursuant to Section 4.3 of Supreme Court Rule 9 due to Mr. Lopez's substantial non-compliance with his Monitoring Agreement with the Tennessee Lawyers Assistance Program. On July 23, 2010, Mr. Lopez filed a Petition for Dissolution of Temporary Suspension pursuant to Section 4.3 of Supreme Court Rule 9.

On August 5, 2010, a hearing was conducted before a three-member Hearing Panel of the Board of Professional Responsibility. On August 6, 2010, the Hearing Panel entered its Report and Recommendation, recommending that the temporary suspension imposed by the Order of Temporary Suspension be dissolved. A copy of the Report and Recommendation of the 4.3 Hearing Panel is attached hereto and incorporated herein by reference.

It is, therefore, **ORDERED, ADJUDGED and DECREED** that:

1. The temporary suspension imposed upon Ivan Omar Lopez by Order of Temporary Suspension filed July 22, 2010, is hereby dissolved and Ivan Omar Lopez is reinstated to the practice of law;
2. Mr. Lopez shall reimburse and pay to the Board of Professional Responsibility the costs and expenses of this proceeding in the amount of \$268.33, and, in addition, shall pay to the Clerk of this Court the costs incurred herein, for all of which execution shall issue, if necessary.
