**ORDER OF ENFORCEMENT**

This matter is before the Court upon a Petition for Discipline filed against Jedidiah Charles McKeehan on June 23, 2023; upon Mr. McKeehan's Answer to Petition for Discipline filed through his Counsel on August 14, 2023; upon entry of Findings of Fact, Conclusions of Law and Judgment of the Hearing Panel on August 15, 2024; upon service of the Findings of Fact, Conclusions of Law and Judgment of the Hearing Panel on Mr. McKeehan by the Executive Secretary of the Board on August 15, 2024; upon consideration and approval by the Board on September 13, 2024; upon expiration of the appeal period with no appeal taken; and upon the entire record in this cause.

From all of which, the Court approves the Judgment of the Hearing Panel and adopts the Hearing Panel's Judgment of active suspension.

IT IS, THEREFORE, CONSIDERED, ORDERED, ADJUDGED, AND DECREED BY THE COURT THAT:

(1) Mr. McKeehan is suspended from the practice of law for thirty (30) days, to be served as an active suspension pursuant to Tenn. Sup. Ct. R. 9, § 12.2. Mr. McKeehan may apply for reinstatement at the end of the thirty (30) day active suspension.

(2) Prior to seeking reinstatement, Mr. McKeehan must have met all CLE requirements; have remitted all outstanding registration fees and outstanding professional privilege taxes, including those due from the date of this suspension until the date of reinstatement; and have remitted all court costs and Board costs in this matter. In addition, Mr. McKeehan shall be in substantial compliance with the terms and conditions of this Order.

(3) Mr. McKeehan shall comply in all aspects with Tenn. Sup. Ct. R. 9, §§ 28 and 30.4, regarding the obligations and responsibilities of suspended attorneys and the procedure for reinstatement.

(4) Pursuant to Tenn. Sup. Ct. R. 9, § 31.3(d), Mr. McKeehan shall pay to the Board of Professional Responsibility the expenses and costs incurred to date by the Board in this matter in the amount of \$3,682.00, which includes \$100.00 for the cost of filing this matter, and shall pay to the Clerk of this Court the court costs incurred herein. All costs, fees, and expenses awarded or assessed herein shall be paid within ninety (90) days of the entry of this Order for which execution, if necessary, may issue.

(5) The Board of Professional Responsibility shall cause notice of this discipline to be published as required by Tenn. Sup. Ct. R. 9, § 28.11.

(6) Pursuant to Tenn. Sup. Ct. R. 9, § 28.1, this Order shall be effective upon entry.
