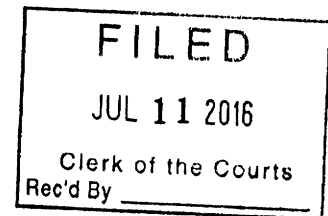

ORDER OF ENFORCEMENT

This matter is before the Court pursuant to Tenn. Sup. Ct. R. 9, § 22.3, upon a Notice of Submission filed by Disciplinary Counsel for the Board of Professional Responsibility consisting of a certified copy of the Jury Verdict entered June 13, 2016, in the United States District Court for the Eastern District of Tennessee, in the matter of *United States of America v. Everett H. Mechem* (attached as Exhibit A), demonstrating that Everett H. Mechem, a Tennessee attorney, was found guilty of the following serious crimes: Title 18 United States Code Section 1343: Wire Fraud; Title 42 United States Code Section 1383a(a)(3): Supplemental Security Income Fraud; Title 18 United States Code Section 1001: False Statement; and Title 18 United States Code Section 641: Theft of Public Money.

IT IS THEREFORE, CONSIDERED, ORDERED, ADJUDGED AND DECREED BY THE COURT THAT:

1. Everett H. Mechem is suspended from the practice of law on this date pending further orders of this Court, pursuant to Tenn. Sup. Ct. R. 9, Section 22.3;
2. This matter is referred to the Board of Professional Responsibility for the institution of a formal proceeding in which the sole issue to be determined shall be the extent of the final discipline;
3. Everett H. Mechem shall fully comply with the provisions of Tenn. Sup. Ct. R. 9, Section 28, concerning disbarred or suspended attorneys; and

4. The Board of Professional Responsibility shall cause notice of this suspension to be published as required by Tenn. Sup. Ct. R. 9, Section 28.11.
