Mechem, a Tennessee attorney, was found guilty of the following serious crimes: Title 18 United States Code Section 1343: Wire Fraud; Title 42 United States Code Section 1383a(a)(3): Supplemental Security Income Fraud; Title 18 United States Code Section 641: Theft of Public Money.

- 1. Everett H. Mechem is suspended from the practice of law on this date pending further orders of this Court, pursuant to Tenn. Sup. Ct. R. 9, Section 22.3;
- 2. This matter is referred to the Board of Professional Responsibility for the institution of a formal proceeding in which the sole issue to be determined shall be the extent of the final discipline;
- 3. Everett H. Mechem shall fully comply with the provisions of Tenn. Sup. Ct. R. 9, Section 28, concerning disbarred or suspended attorneys; and

4. The Board of Professional Responsibility shall cause notice of this suspension to be published as required by Tenn. Sup. Ct. R. 9, Section 28.11.
