**NASHVILLE LAWYER CENSURED**

On September 23, 2011, Jennifer Meehan of Nashville, Tennessee was publicly censured by the Tennessee Supreme Court pursuant to Supreme Court Rule 9, Section 4.4. Ms. Meehan violated the Rules of Professional Conduct by submitting a false resume to a potential employer and making false statements to disciplinary counsel for the Board. Ms. Meehan's actions violated Tennessee Supreme Court Rule 8, Rule of Professional Conduct 7.1 (Communications Concerning a Lawyer's Services), 8.1 (Bar Admission and Disciplinary Matters) and 8.4 (Misconduct). Ms. Meehan was further ordered to pay the expenses and costs of the disciplinary proceedings against her, pursuant to Rule 9, Section 24.3, of the Rules of the Supreme Court.

For these violations, the Supreme Court of Tennessee publicly censured Jennifer Meehan. A public censure is a rebuke and warning to the attorney, but it does not affect the attorney's ability to practice law.

**ORDER OF ENFORCEMENT**

This matter is before the Court upon a Petition for Discipline filed by Disciplinary Counsel against Jennifer Meehan, on February 25, 2011; upon a Motion for Default and that Allegations Contained in Petition for Discipline Be Deemed Admitted filed by the Board on April 28, 2011; upon an Order Granting the Motion for Default entered by the Hearing Panel on June 7, 2011; upon a Conditional Guilty Plea executed by Ms. Meehan on July 14, 2011 and filed with the Board on July 18, 2011; upon an Order of Recommendation of Conditional Guilty Plea entered by the Hearing Panel on July 18, 2011; upon the Board's approval of the Conditional Guilty Plea on September 9, 2011; and upon the entire record in this cause.

From all of which the Court approves the recommendation of the Hearing Panel and accepts the Conditional Guilty Plea.

It is, therefore, **ORDERED, ADJUDGED** and **DECREED** by the Court,

1. Jennifer Meehan is hereby publicly censured pursuant to Rule 9, §4.4 of the Rules of the Supreme Court.
2. Pursuant to Supreme Court Rule 9, Section 24.3, Ms. Meehan shall pay to the Board of Professional Responsibility the expenses and costs of this matter in the amount of \$341.67 and in addition, shall pay to the Clerk of this Court the costs incurred herein, within ninety (90) days from the entry of this order, for all of which execution may issue if necessary.
3. The Board of Professional Responsibility shall cause notice of this discipline to be published as required by Supreme Court Rule 9, Section 18.10.
