ORDER OF ENFORCEMENT

This matter is before the Court pursuant to Tenn. Sup. Ct. R. 9, § 22.3, upon a Notice of Submission filed by Disciplinary Counsel for the Board of Professional Responsibility consisting of a certified copy of the *Verdict Sheet* filed in the Criminal Circuit Court for Sumner County, Tennessee, in *State of Tennessee v. Jocelyn Doria Mims*, Docket Case No. 2023-CR-633 (attached hereto as Collective Exhibit A), demonstrating that Jocelyn Doria Mims, a Tennessee attorney, was adjudged guilty of two (2) felony counts of Tampering with Evidence, one (1) count of Making False Report, and three (3) counts of Intentional Failure to Report Child Sexual Abuse.

IT IS, THEREFORE, CONSIDERED, ORDERED, ADJUDGED, AND DECREED BY THE COURT THAT:

1. Jocelyn Doria Mims is suspended from the practice of law on this date pending further orders of this Court, pursuant to Tenn. Sup. Ct. R. 9, § 22.3;
2. This matter is referred to the Board of Professional Responsibility for the institution of a formal proceeding in which the sole issue to be determined shall be the extent of the final discipline;
3. Jocelyn Doria Mims shall fully comply with the provisions of Tenn. Sup. Ct. R. 9, § 28, concerning suspended attorneys; and
4. The Board of Professional Responsibility shall cause notice of this suspension to be published as required by Tenn. Sup. Ct. R. 9, § 28.11.
