**TENNESSEE LAWYER PLACED ON DISABILITY INACTIVE STATUS**

By Order of the Tennessee Supreme Court entered March 20, 2019, the law license of Robert Mark Morgan was transferred to disability inactive status pursuant to Section 27.3 of Tennessee Supreme Court Rule 9.

Mr. Morgan cannot practice law while on disability inactive status. He may return to the practice of law after reinstatement by the Tennessee Supreme Court upon showing of clear and convincing evidence that the disability has been removed and he is fit to resume the practice of law.

**ORDER TRANSFERRING ATTORNEY TO  
DISABILITY INACTIVE STATUS**

This matter is before the Court upon a petition to transfer Robert Mark Morgan to disability inactive status filed by the Tennessee Board of Professional Responsibility pursuant to Tenn. Sup. Ct. R. 9, § 27.3.

Upon due consideration of documentation from the Social Security Administration submitted by Robert Mark Morgan, the Court concludes that Mr. Morgan is currently incapacitated from continuing the practice of law.

IT IS, THEREFORE, CONSIDERED, ORDERED, ADJUDGED AND DECREED BY THE COURT THAT:

1. The law license of Robert Mark Morgan shall be transferred to disability inactive status for an indefinite period of time and until further orders of the Supreme Court.
2. Robert Mark Morgan shall be allowed to petition for reinstatement to active status pursuant to Tenn. Sup. Ct. R. 9, § 27.7.
3. The Board shall publish notice of this transfer pursuant to Tenn. Sup. Ct. R. 9, §§ 27.5 and 28.11.
4. Pursuant to Tenn. Sup. Ct. R. 9, § 32.4, documents other than this Order relating to Mr. Morgan's disability proceeding shall not be public records and shall be kept confidential.
