**FINAL ORDER IMPOSING SANCTION**

---

This matter came to be heard on January 26, 2016, on the submissions of the Parties to the Panel, the testimony of Respondent and other witnesses before the Panel, the oral arguments of the Parties at the hearing, and the record as a whole. Based on the foregoing, the Panel finds as follows:

1. On July 23, 2015, the Panel entered its Order on Dispositive and Other Motions, pursuant to which the Panel concluded that Respondent violated Rules 3.5(e), 8.2(a), 8.4(a), and 8.4(d) of the Rules of Professional Conduct. The Panel also concluded that Respondent had not violated Rule 8.4(c) of the Rules of Professional Conduct.

2. The purpose of the January 26, 2016 hearing was to allow the Parties the opportunity to present evidence and argument to the Panel regarding the appropriate level of sanction to be imposed based on the aforementioned violations of the Rules of Professional Conduct.

3. Pursuant to Section 15.4, Rule 9 of the Rules of the Supreme Court, the Panel considered the applicable provisions of the ABA Standards for Imposing Lawyer Sanctions.

4. As such, the Panel considered, *inter alia*, the duty violated, Respondent's mental state, the injury caused by Respondent's misconduct, and the existence of aggravating and mitigating factors. (*See*, Standards for Imposing Lawyer Sanctions, Sec. 3.0.)

WHEREFORE, PREMISES CONSIDERED, the Panel orders that, as a result of the conduct at issue, Respondent should be publicly censured.
