**MEMPHIS LAWYER TEMPORARILY SUSPENDED**

On April 8, 2010, the Supreme Court of Tennessee temporarily suspended the law license of Timothy Allen Price, of Memphis, Tennessee, pursuant to Section 4.3 of Rule 9 of the Rules of the Tennessee Supreme Court. The Board of Professional Responsibility petitioned the Court to temporarily suspend Mr. Price's law license because he failed to respond to a disciplinary complaint of ethical misconduct and because he poses a threat of substantial harm to the public.

The Order precludes Mr. Price from accepting any new cases as of April 8, 2010. Mr. Price was permitted to represent existing clients until May 10, 2010. After May 10, 2010, Mr. Price shall not maintain a presence or occupy an office where the practice of law is conducted. Mr. Price shall take such action as is necessary to cause the removal of any indicia of lawyer, counselor at law, legal assistant, law clerk, or similar title.

The Order requires Mr. Price to notify all clients, co-counsel, and opposing counsel in pending matters of the Supreme Court's Order suspending his law license.

This suspension remains in effect until dissolution or modification by the Supreme Court. Mr. Price may for good cause request dissolution or modification of this suspension by petition to the Supreme Court of Tennessee.

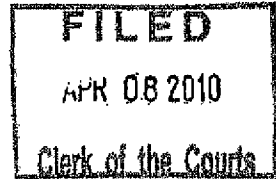

**ORDER OF TEMPORARY SUSPENSION**

This matter is before the Court on a Petition of the Board of Professional Responsibility of the Supreme Court of Tennessee, by and through Disciplinary Counsel, for the temporary suspension of Timothy Allen Price, from the practice of law, pursuant to Section 4.3 of Supreme Court Rule 9. The Petition has been authorized by the Chair of the Board of Professional Responsibility and is supported by the affidavits of Preston Shipp, Disciplinary Counsel, and Terry Smart, Jr., Esquire.

Based upon the Petition and the supporting Affidavits, the Court finds that Timothy Allen Price, Respondent, has failed to respond to the Board of Professional Responsibility concerning a complaint of misconduct and poses a threat of substantial harm to the public.

It is therefore, **ORDERED, ADJUDGED** and **DECREED** by the Court that:

1. Timothy Allen Price is hereby temporarily suspended from the practice of law as provided in Section 4.3 of Supreme Court Rule 9.
2. Timothy Allen Price shall comply with Supreme Court Rule 9 in all respects, and particularly as provided in Section 18.
3. Timothy Allen Price may make application for dissolution or modification of this Order as provided in Supreme Court Rule 9.

4. The Board of Professional Responsibility shall cause notice of this suspension of Timothy Allen Price to be published as required by Supreme Court Rule 9.
