**ORDER OF ENFORCEMENT**

This matter is before the Court upon a Petition for Discipline filed against Robert R. Rexrode on March 2, 2022; upon a Motion for Default Judgment and That Charges in Petition for Discipline be Deemed Admitted filed by the Board of Professional Responsibility (“Board”) on July 26, 2022; upon Order for Default Judgment entered by Hearing Panel on September 6, 2022; upon service of the Order for Default Judgment on Mr. Rexrode by the Executive Secretary of the Board on September 6, 2022; upon Findings of Fact, Conclusions of Law, and Judgment entered by the Hearing Panel on January 18, 2023; upon service of Findings and Fact, Conclusions of Law and Judgment on Mr. Rexrode by the Executive Secretary of the Board on January 18, 2023; upon Board’s Application for Assessment of Costs entered on January 27, 2023; upon the Findings and Judgment for Assessment of Costs entered by the Hearing Panel on March 9, 2023; upon service of the Findings and Judgment for Assessment of Costs on Mr. Rexrode by the Executive Secretary of the Board on March 9, 2023; upon consideration and approval of the Hearing Panel’s Order by the Board on March 10, 2023; upon expiration of the appeal period with no appeal taken; and upon the entire record in this cause.

From all of which, the Court approves the Findings of Fact, Conclusions of Law, and Judgment of the Hearing Panel and adopts the Hearing Panel’s order of permanent disbarment.

On September 25, 2020, Mr. Rexrode was suspended by this Court from the practice of law pursuant to Tenn. Sup. Ct. R. 9, § 12.3 (M2020-01313-SC-BAR-BP). To date, Mr. Rexrode has not requested, nor been granted, reinstatement.

IT IS, THEREFORE, CONSIDERED, ORDERED, ADJUDGED, AND DECREED BY THE COURT THAT:

(1) Mr. Rexrode is permanently disbarred from the practice of law pursuant to Tenn. Sup. Ct., R. 9 § 12.1.

(2) Mr. Rexrode shall comply in all aspects with Tenn. Sup. Ct. R. 9, § 28, regarding the obligations and responsibilities of disbarred attorneys.

(3) Pursuant to Tenn. Sup. Ct. R. 9, § 31.3(d), Mr. Rexrode shall pay to the Board of Professional Responsibility the expenses and costs incurred to date by the Board in this matter in the amount of \$2,300.00, which includes \$100.00 for the cost of filing this matter and shall pay this filing fee to the Board and shall pay to the Clerk of this Court the court costs incurred herein. All costs, fees, and expenses awarded or assessed herein shall be paid within ninety (90) days of the entry of this Order for which execution, if necessary, may issue.

(4) The Order of Temporary Suspension entered on September 25, 2022, in Case No. M2022-00313-SC-BAR-BP is hereby dissolved.

(5) The Board of Professional Responsibility shall cause notice of this discipline to be published as required by Tenn. Sup. Ct. R. 9, § 28.11.

(6) Pursuant to Tenn. Sup. Ct. R. 9, § 28.1, this Order shall be effective upon entry.
