**DAVIDSON COUNTY LAWYER CENSURED**

On August 12, 2013, Shawn Patrick Sirgo, an attorney licensed to practice law in Tennessee, received a Public Censure from the Board of Professional Responsibility of the Tennessee Supreme Court.

Shawn Patrick Sirgo practiced law while his license to do so was suspended. By these acts, Mr. Sirgo violated Rule of Professional Conduct 5.5 (unauthorized practice of law) and is hereby Publicly Censured for this violation.

A Public Censure is a rebuke and warning to the attorney, but it does not affect the attorney's ability to practice law.




PUBLIC CENSURE

The above complaints were filed against Shawn Patrick Sirgo, an attorney licensed to practice law in Tennessee, alleging certain acts of misconduct. Pursuant to Tenn. Sup. Ct. R. 9, the Board of Professional Responsibility considered these matters at its meeting on June 14, 2013. In two separate cases, Mr. Sirgo practiced law while his license to do so was suspended, in violation of Rule 5.5. By the aforementioned acts, Shawn Patrick Sirgo violated Rule of Professional Conduct 5.5 (unauthorized practice of law) and is hereby Publicly Censured for this violation.
