WILSON COUNTY LAWYER TEMPORARILY SUSPENDED

On April 17, 2015, the Supreme Court of Tennessee temporarily suspended Patricia Lynne Stolinsky from the practice of law upon finding that Ms. Stolinsky has failed to respond to the Board regarding a complaint of misconduct. Section 12.3 of Supreme Court Rule 9 provides for the immediate summary suspension of an attorney's license to practice law in cases of an attorney's failure to respond to the Board regarding a complaint of misconduct.

Effective April 17, 2015, Ms. Stolinsky is precluded from accepting any new cases and she must cease representing existing clients by May 17, 2015. After May 17, 2015, Ms. Stolinsky shall not use any indicia of lawyer, legal assistant, or law clerk nor maintain a presence where the practice of law is conducted.

Ms. Stolinsky must notify all clients being represented in pending matters, as well as co-counsel and opposing counsel of the Supreme Court's Order suspending her law license. Section 28 of Supreme Court Rule 9 requires Ms. Stolinsky to deliver to all clients any papers or property to which they are entitled.

This suspension remains in effect until dissolution or modification by the Supreme Court. Ms. Stolinsky may for good cause request dissolution or modification of the suspension by petition to the Supreme Court.

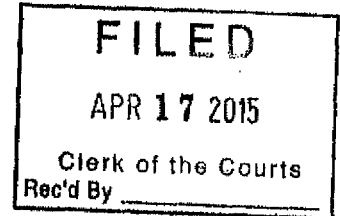

ORDER OF TEMPORARY SUSPENSION

This matter is before the Court on a Petition of the Board of Professional Responsibility of the Supreme Court of Tennessee, by and through Disciplinary Counsel, for the temporary suspension of Patricia Lynne Stolinsky from the practice of law, pursuant to Tenn. Sup. Ct. R. 9, § 12.3 (2014). The Petition has been authorized by the Chair of the Board of Professional Responsibility and is supported by the Affidavit of Elizabeth C. Garber, Disciplinary Counsel.

Based upon the Petition and the supporting Affidavit, the Court finds that Patricia Lynne Stolinsky, Respondent, has failed to respond to the Board of Professional Responsibility concerning a complaint of misconduct.

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED BY THE COURT THAT:

1. Patricia Lynne Stolinsky is hereby temporarily suspended from the practice of law as provided in Tenn. Sup. Ct. R. 9, § 12.3 (2014).
2. Patricia Lynne Stolinsky shall comply with Tenn. Sup. Ct. R. 9 in all respects and particularly as provided in Tenn. Sup. Ct. R. 9, § 30 (2014).
3. Patricia Lynne Stolinsky may make application for dissolution or modification of this Order as provided in Tenn. Sup. Ct. R. 9, § 12.3 (2014).
4. The Board of Professional Responsibility shall cause notice of this suspension of Patricia Lynne Stolinsky to be published as required by Tenn. Sup. Ct. R. 9, § 28.11.
