**CLARKSVILLE LAWYER REINSTATED BY SUPREME COURT**

Cleveland C. Turner has been reinstated to the practice of law by Order of the Tennessee Supreme Court entered January 11, 2013. Mr. Turner's license was transferred to disability inactive status by Order of the Supreme Court on January 14, 1997. On July 6, 2012, Mr. Turner filed a Petition for Reinstatement. A Hearing Panel determined that Mr. Turner should be reinstated to the practice of law upon the conditions that he pay all costs of the disciplinary proceeding, remain in compliance with his TLAP Monitoring Agreement, and resolve any unresolved disciplinary complaints against him. Mr. Turner has met all of the conditions for his reinstatement to the practice of law.

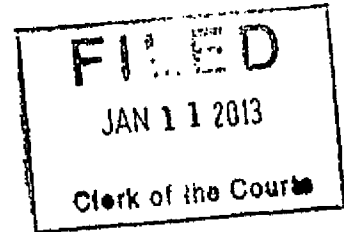

**ORDER OF REINSTATEMENT**

This matter is before the Court upon a Petition for Reinstatement filed by Cleveland C. Turner on July 6, 2012; upon an Answer to Petition For Reinstatement filed by the Board on August 13, 2012; upon a Supreme Court Order filed August 23, 2012, referring the matter to a Hearing Panel; upon a hearing held on October 22, 2012; upon the Judgment of the Hearing Panel entered on October 22, 2012; upon approval from the Board of Professional Responsibility on December 14, 2012; and upon the entire record in this case.

From all of which the Court accepts and adopts the Judgment of the Hearing Panel as the Court's Order.

It is therefore, ordered, adjudged, and decreed by the Court that:

1. Petitioner, Cleveland C. Turner, is hereby reinstated to the practice of law in the State of Tennessee conditioned upon:

- a. Payment of all costs of the disciplinary proceeding pursuant to Tenn. Sup. Ct. R. 9, §24.3;
- b. Completion of his current contract with the Tennessee Lawyer's Assistance Program which ends January 14, 2014; and
- c. The resolution of any unresolved disciplinary complaints against him.

2. Pursuant to Tenn. Sup. Ct. R. 9, §24.3, Mr. Turner shall pay to the Board of Professional Responsibility the expenses and costs of this matter in the amount of \$1,336.00 and in addition, shall pay to the Clerk of this Court the costs incurred herein, within ninety (90) days from the entry of this Order, for all of which execution may issue if necessary.

3. The Board of Professional Responsibility shall cause notice of this reinstatement to be published.
