ORDER AMENDING JUDGMENT

The parties have filed a Joint Motion to Alter or Amend the hearing panel's Opinion which was entered on May 7, 2018. Specifically, the parties requested that the hearing panel's Opinion be amended to refer to the conditions from the Tennessee Supreme Court's original Order of Enforcement instead of imposing different conditions.

A subsequent conference call was conducted between the hearing panel and counsel for each of the parties on May 11, 2018. The requirement that the Petitioner be required to obtain legal malpractice insurance, and to maintain said policy throughout the course of his practice, was discussed during the call. Petitioner's counsel indicated his client would look into obtaining such a policy and report back to the hearing panel. On June 6, 2018, the hearing panel was provided with documentation which showed Petitioner has in fact obtained a policy of professional liability insurance.

Premises considered, the panel has agreed to amend the "Order" section of its prior Opinion, and the following be substituted in its place:

ORDER

Based on the Findings of Fact and Conclusions of Law set forth in its prior Opinion, and the findings contained in this Order,

It is hereby ORDERED, ADJUDGED and DECREED as follows:

1. Petitioner is reinstated to the practice of law as an attorney in good standing in the State of Tennessee. The Petitioner shall serve the period of probation provided for by the Order of ORDER AMENDING JUDGMENT

Enforcement of September 26, 2016, subject to the conditions provided for in that Order.

2. Petitioner shall also be required to obtain legal malpractice insurance, and to maintain said policy throughout the course of his practice.
