DAVIDSON COUNTY LAWYER CENSURED

On April 15, 2021, Memorie Kristina White, an attorney licensed to practice law in Tennessee, received a Public Censure from the Board of Professional Responsibility of the Tennessee Supreme Court.

Ms. White, with knowledge that a corporation was represented by counsel, knowingly contacted corporate employees and negotiated a reduction of a judgment lien held by the corporation.

By this act, Memorie Kristina White has violated RPC 4.2 (communication with a person represented by counsel) and is hereby Publicly Censured for this violation.

A Public Censure is a rebuke and warning to the attorney, but it does not affect the attorney's ability to practice law.


PUBLIC CENSURE

The above complaint was filed against Memorie Kristina White, #025109, an attorney licensed to practice law in Tennessee, alleging certain acts of misconduct. Pursuant to Tenn. Sup. Ct. R. 9, the Board of Professional Responsibility considered this matter at its meeting on March 12, 2021.

Ms. White is owner and operator of a title company. Ms. White, with knowledge that a corporation was represented by counsel, knowingly contacted corporate employees and negotiated a reduction of a judgment lien held by said corporation.

By the aforementioned acts, Memorie Kristina White has violated Rule of Professional Conduct 4.2 (Communication with a person represented by counsel) and is hereby Publicly Censured for this violation.
